HARMONISATION - A COMMON ASEAN LEGAL FRAMEWORK

[6] The harmonization of laws within the ASEAN region and the establishment of an ASEAN legal framework have yielded positive outcomes such as facilitating cross-border transactions, trade and commerce, the flow of capital and resources, as well as the exchange of knowledge. Above all, it creates a stable, transparent, and predictable environment for trade, businesses, and commerce to strive within ASEAN.

THE GROWING IMPORTANCE OF ALA

[7] Apart from legal harmonization, ALA being a melting pot of legal professionals consisting of Judges, lawyers, and legal scholars within ASEAN continues to play a vital role in reinforcing diplomatic relations among ASEAN Member States. It is noteworthy to emphasise that ALA

was given a special mandate under the ASEAN Charter as the sole accredited civil society organisation for law by ASEAN, to strengthen ASEAN legal cooperation and the development of legal frameworks and infrastructure within ASEAN.

[8] Our multilateral cooperation does not stop with ASEAN. It extends to beyond this region to develop strategic partnerships globally. In my view, these efforts for cooperation beyond ASEAN strengthen the much-needed global ties, especially in upholding the Rule of Law, promoting judicial education and training, and the developing solutions for uncommon issues of the present and future alike.

INITIATIVES AND COLLABORATIONS OF ALA

[9] As we gather on this occasion of the 44th ALA Governing Council Meeting, we look forward to the many significant initiatives undertaken, overseen, or supervised by ALA, including the various Working Groups and Standing Committees under ALA, and most notably the ASEAN Law Institute ("AsnLI").

[10] The establishment of the AsnLI, in my view is a significant affirmation to ALA's devotion for the realisation of the ASEAN Motto of "One Vision, One Identity, One Community". The AsnLI is instrumental in the advancement of ALA's objectives, mission, and vision as it supports ALA's core functions. The AsnLI works hand in hand to support the various policies advocated by ALA, ALA's National Committees, Standing Committees, Ad Hoc Committees, and sub-committees.
